Scope & Content: Menominee Tribal Legislature (MTL) and Menominee Tribal Enterprises (MTE) disagreed over authoritative ownership of MTE's forest management plan (FMP). The two entities each created their own FMP and submitted them to the Midwest Regional Director of the Bureau of Indian Affairs for approval. The acting Regional Director responded by saying she was not able to approve either plan, on the grounds that the issue was creating intra-tribal conflict. MTE then filed a lawsuit against the Regional Director in 2011, claiming the Regional Director and MTL sought to alter the structured relationship between MTE, MTL, and the Menominee people set forth after Restoration.

The Menominee Tribe of Wisconsin (MITW) is working with state, local, and tribal officials to secure approval for construction of an \$800 million dollar casino complex on ancestral grounds in Kenosha, WI. MITW and partners, Hard Rock International, received approval from the US Department of the Interior in August of 2013. They are currently awaiting approval from Wisconsin Governor Scott Walker before construction can begin.

This collection contains emails, letters, reports, Powerpoint slides, certifications, resolutions, and articles related to the Forestry Management Plan dispute between Menominee Tribal Legislature and Menominee Tribal Enterprises, as well as papers and reports in support of the approval of the Kenosha Casino Project.
